Tim Kihm and Sam Elias, representing the applicant, Flying Flags RV Resort and Campground, provided a presentation regarding their request to add solar energy structures adjacent to the RV Resort on Avenue of Flags.

Public comments were received and made part of the record from Buellton residents Mark & Jill Cavanaugh and Hudson Hornick opposing the proposed solar energy structures.

- Adding the solar panels on private property rather than on Avenue of Flags

- Allowing private businesses to use City owned property and the private/public benefit that would come from the project
- Installation of solar panels qualifies for a federal tax credit
