LAND USE EXEMPTION / ZONING CLEARANCE FOR ELECTRIC VEHICLE CHARGING STATIONS (APPLICATION CHECKLIST)

Reference [Buellton Municipal Code](#) Sections 19.02.030, 19.06.280 and 19.08.100

- Items listed on this Checklist must be submitted to the City Planning Department for a complete application. Conformance with the eligibility checklist (#4 below) determines if the project qualifies for expedited permitting. The application package for expedited permitting will be reviewed over-the-counter for a Land Use Exemption and within 5 business days for a Zoning Clearance. After City of Buellton review and approval of the Land Use Exemption or Zoning Clearance, a separate application for a Building Permit will need to be submitted to the Santa Barbara County Building & Safety Division.
- **Submittal Format** - You may choose to submit only a digital copy of the plans, without providing physical copies.
 - Electronic Plans: Please submit all plans and documents as PDF. Fully dimensioned plans are required for electronic submittals. They may be emailed to planning@cityofbuellton.com
 - Physical Plans: If physical copies are submitted, please submit two copies. Physical plans must be to scale. They may be dropped off at the Planning Department office at 331 Park Street or mailed to P.O. Box 1819, Buellton, CA 93427. The following sizes will be accepted, and depend on the complexity of the project:
 - 8 1/2" x 11"
 - 11" x 17"
 - Or 24" x 36"
 - Reports/Studies: Submit a digital copy only. They may be emailed to planning@cityofbuellton.com

3. **Site Plan and Electrical Plan** – Include the following:
 - a) Location, size, and use of all structures
 - b) Location of electrical panel for the charging system
 - c) Type of charging system and mounting
 - d) Electric load calculation worksheet
 - e) Existing private and public easements
 - f) Additional information based on response to questions in the eligibility checklist below
